SOLICITATION

The Wyoming Enhanced and Improved Oil Recovery Commission and the School of Energy Resources at the University of Wyoming invite nominations and applications for the position of **Director, Enhanced and Improved Oil Recovery Institute** (EORI). The EORI is a well-established organization, which is currently undergoing a re-examination of the organization's focus in carrying out its statutory duties to the State of Wyoming.

OPPORTUNITY

The Director, with the guidance of the Wyoming Enhanced and Improved Oil Recovery Commission (Commission) and the School of Energy Resources (SER) will collaboratively develop the new focus for EORI, develop an implementation plan and subsequently manage its deployment. The Director will report administratively to the Director of SER and interact directly with the Commission for guidance. Compensation will be commensurate with experience.

SCOPE

The Director will:

Re-evaluate the legislative mandate and synchronize the mission of the Institute with the fundamental objective of recovering more oil and transferring technical knowledge to the oil and gas industry. The Director will employ a variety of tools, analysis, technical and non-technical approaches to accelerate hydrocarbon production within the State of Wyoming. The Director will work with a number of State agencies and the oil and gas industry to accomplish the mission and objectives.

CREDENTIALS, QUALIFICATIONS AND EXPERIENCE

Required:

- 1) Science or engineering degree
- 2) At least 10 years of experience in the oil and gas industry

Highly desirable:

- 1) Demonstrated experience in reservoir engineer or related field with strong technical skills, enhanced or improved oil recovery experience preferred
- 2) Demonstrated organization/management/leadership performance with experience in building an organization
- 3) Demonstrated work with multi-discipline and diverse workforce

- 4) Documented examples of performance as a team player
- 5) Documented examples of taking initiative, goal orientation and delivering results
- 6) Demonstrated superior communication skills across many venues; The Director will build relationships and communicate with the EORI Commission, SER leadership, EORI staff, the Governor, the Legislature, industry and academia
- 7) Demonstrated examples of solid industry relationships including small, medium and large companies inside and external to Wyoming
- 8) Documented examples of leading by example
- 9) Wyoming experience a plus but not required
